Introduction

This Privacy Policy explains in detail the types of personal information we may collect about you when you interact with us. How we collect or obtain information about yourself

'We' may receive your information via the Exhibition Organiser or via third-party service providers, agent's subcontractors and other associated organisations for the purposes of completing tasks and providing services to you on their behalf.

'We' may receive your information directly from you (Exhibitor, Contractor or Supplier), for the purposes of completing tasks and providing services to support your participation in the event and your contractual obligations with the Organiser(s).

Information we collect.

We collect; contact name, company name, company address, telephone, email and if applicable Invoice details for payment of services and additional construction fees such as engineer inspections.

How we use your information

To carry out our obligations arising from any contracts entered between ourselves, the Organisers and the Venues to provide you with the information, products and services that you request from us;

To notify you regarding your obligations arising from contracts between yourselves (Exhibitors) and the Organisers.

To notify you about changes to our services or ask your opinion on the services that we provide,

To notify you about changes in regulations,

To ensure that content from our site is presented in the most effective manner for you and for your computer,

To provide the 'Organisers' with regular updates on the success of our service.

Disclosure of your information to third parties

We may share your information with selected third parties including: The Venue in which your event is being held, The Organisers, and sub-contractors who are working for us to fulfil our services.

If we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets.

If we are under a duty to disclose or share your personal data to comply with any legal obligation, or to enforce or apply our terms of use or terms and conditions of supply and other agreements; or to protect the rights, property, or safety of Event Support Solutions Ltd, our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

We may provide to sub-contractors (including but not limited to, sub-contractors of the Organisers in which you have entered into a contract with or our own sub-contractors who may be delivering a business process on our behalf.

Do we sell your information to third parties?

Under no circumstances do we sell your information to third parties.

How long do we retain your information?

We are obligated to keep our data for a minimum of 3 years.

How we secure your information

Your data is stored on the Event Support Solutions hard drive at our operations address, Office G2, The Old Town Hall, Ferneberga House, Alexandra Road, Farnborough, Hampshire, GU14 6DQ.

We have safeguards in place to ensure your data is secure.

Use of cookies - Including cookie policy

A cookie is a piece of data stored locally on your computer and contains information about your activities on the Internet. The information in a cookie does not contain any personally identifiable information you submit to our site.

On our website, we use cookies to track users' progress through the website, allowing us to make improvements based on usage data. Transfers of your information outside the European Economic Area
